SHIFTING ORDER

WHEREAS, in terms of Section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to JAWAHARLAL NEHRU COLLEGE, C-56, CIVIL LINES, SHYAMALA HILLS, BHOPAL, PIN CODE - 462002, MADHYA PRADESH for B.Ed. course vide order dated 09.08.2005, 26-10-2006, 01-08-2008 for an annual intake of 100 seats.

AND WHEREAS, Revised order for two basic units of 50 students each was issued on 31.05.2015.

AND WHEREAS, the institution applied under clause 8 (11) of NCTE Regulations 2009, for change of premises from JAWAHARLAL NEHRU COLLEGE, C-56, CIVIL LINES, SHYAMALA HILLS, BHOPAL, PIN CODE - 462002, MADHYA to JAWAHARLAL NEHRU COLLEGE, PLOT NUMBER 973/1, VILLAGE/TOWN - MUGALIA HAT, POST OFFICE - FANDA, TEHSIL/TALUKA - HUZUR, DISTRICT - BHOPAL, MADHYA PRADESH.

AND WHEREAS, the inspection of the institution was conducted in its new premises on 30-01-2016.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before WRC in its **242nd Meeting held on February 11-13, 2016** and the Committee observed that "...The case file was seen. This is a case of shifting. The institute runs the B.Ed. course with two units, B.P.Ed., M.Ed. and M.P.Ed. courses with one unit each and it has applied for the D.El.Ed. course.

The CD was viewed and VT report was perused. The CD shows a good building with adequate infrastructural and instructional facilities. The institute has sufficient land and built up area to run the above mentioned courses. The VT has recommended the case.

Hence, the institute is permitted to shift."

NOW THEREFORE, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, the permission under clause 8(9) of NCTE Regulations, 2014, is hereby granted for change of premises from JAWAHARLAL NEHRU COLLEGE, C-56, CIVIL LINES, SHYAMALA HILLS, BHOPAL, PIN CODE - 462002, MADHYA to JAWAHARLAL NEHRU COLLEGE, PLOT NUMBER 973/1, VILLAGE/TOWN - MUGALIA HAT, POST OFFICE - FANDA, TEHSIL/TALUKA - HUZUR, DISTRICT - BHOPAL, MADHYA PRADESH for conducting B.Ed. course with immediate effect.

RECOGNITION ORDER

AND WHEREAS, the institution, **JAWAHARLAL NEHRU COLLEGE OF EDUCATION, RUN BY PRAGATI SHIKSHAN SAMITI, PLOT NUMBER 973/1, VILLAGE/TOWN - MUGALIA HAT, POST OFFICE - FANDA, TEHSIL/TALUKA - HUZUR, DISTRICT - BHOPAL, PIN CODE- 462002, MADHYA PRADESH (APW08244/222543)** has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **245th meeting held on March 1-3, 2016** was satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **D.El.Ed.** programme, such as infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants permission to **JAWAHARLAL NEHRU COLLEGE OF EDUCATION, RUN BY PRAGATI SHIKSHAN SAMITI, PLOT NUMBER 973/1, VILLAGE/TOWN - MUGALIA HAT, POST OFFICE - FANDA, TEHSIL/TALUKA - HUZUR, DISTRICT - BHOPAL, PIN CODE- 462002, MADHYA PRADESH** for conducting **D.El.Ed.** programme of 2 (Two) years duration with an annual intake of **50 students (one basic unit)** from the academic session **2016-2017**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.


The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provisions of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1993.


