ORDER

WHEREAS, in terms of section 15(3) (a) of the NCTE Act 1993, WRC granted recognition to JAWAHARLAL NEHRU P.G. COLLEGE, 56-C, OPP. KHUSBOO PARK, T.T. Nagar BHOPAL - 462002, MADHYA PRADESH for M.ED. course vide order dated 18.08.2008 for an annual intake of 25 students.

AND WHEREAS, WRC issued Revised Recognition Order to JAWAHARLAL NEHRU P.G. COLLEGE (co-ed), 56-C, OPP. KHUSBOO PARK, T.T. Nagar BHOPAL - 462002, MADHYA PRADESH vide order dated 20.05.2015 for conducting M.ED. course of two year duration with an annual intake of 50 students (one basic unit) from the academic session 2016-2017.

AND WHEREAS, the institution applied under clause B(11) of NCTE Regulations 2009, for change of premises of M.ED. course from JAWAHARLAL NEHRU P.G. COLLEGE, 56-C, OPP. KHUSBOO PARK, T.T. Nagar BHOPAL - 462002, MADHYA PRADESH to JAWAHARLAL NEHRU COLLEGE OF EDUCATION, PLOT NO. 973/1, VILLAGE/TOWN - MUGALIA HAT, POST OFFICE - FANDA, TEHSIL/TALUKA - HUZUR, TOWN/CITY - BHOPAL, DISTRICT - BHOPAL, PIN CODE - 462002, MADHYA PRADESH.

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 30.01.2016.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 242<sup>nd</sup> Meeting held on February 11-13, 2016. The Committee decided as under:-

"...The case file was seen. This is a case of shifting. The institute runs the B.Ed. course with two units, B.P.Ed., M.Ed. and M.P.E.D. courses with one unit each and it has applied for the D.El.Ed. course.

The CD was viewed and VT report was perused. The CD shows a good building with adequate infrastructural and instructional facilities. The institute has sufficient land and built up area to run the above mentioned courses. The VT has recommended the case.

Hence, the institute is permitted to shift."

NOW THEREFORE, in exercise of the powers vested under section 15(3)(a) of NCTE Act, 1993, permission under clause 3(9) of NCTE Regulation, 2014, is hereby granted for change of premises from JAWAHARLAL NEHRU P.G.
